Every few years, we, as a club, have a meeting to discuss proposed changes to our constitution and by-laws and after such discussion, we, as a club, vote the changes to go into effect. We then print and distribute new copies of the constitution and by-laws. It is important that all members' voices are heard on these changes. Please make plans to attend the upcoming meetings to let your voice be heard.

Central Oklahoma Classic Chevy Club Constitution and By-Laws

Article 1: Name, Color & Emblem.

Section 1.

The name of the club is Central Oklahoma Classic Chevy Club.

Section 2.

The club colors are red, white & blue.

Section 3.

The emblem of the club is:



Article 2: Objectives & purposes.

Section 1.

To promote interest in and appreciation of all Classic Chevrolet vehicles, especially 1955, 1956 & 1957 Chevrolets.

Section 2.

To conduct club functions and activities with an emphasis on family participation so as to provide a means of common enjoyment for all members.

Section 3.

To promote safety in automobile design, maintenance, driving and overall vehicle operation.

Section 4.

To create good fellowship and sportsmanship among all members of the club.

Section 5.

To provide a means of interchange of ideas and communications between members, other clubs, as well as with the public, press and law enforcement agencies.

Section 6.

To uphold the principles of good government.

Article 3: Membership Requirements and Rules.

Section 1.

There shall be one type of member in the club: ACTIVE. Someone from a member family must attend 2 regular club meetings (with or without your car) plus participate in a club function (car show) each year (with or without your car) to maintain their membership eligibility.

Section 2.

To be eligible for membership in COCCC, you must be a person of good character with a definite interest in the restoration and preservation of classic Chevrolet vehicles (ownership not required).

Section 3.

All members must maintain the safety of their cars to sustain membership.

Section 4.

All active members are entitled to all voting rights, the right to wear or display the club emblem and colors, as well as any other privileges of membership.

Section 5.

Any member may be permanently suspended by a majority vote of the active membership for actions considered to be in definite violation of the objectives and purposes of the club, or for any actions that would bring discredit to the club.

Section 6.

All members will be required to remove club decals, etc., from their vehicles upon selling their vehicles to someone other than another COCCC member, or if that person has been suspended from the club for any reason.

Section 7.

Any and all COCCC merchandise will never be altered in any manner from its original form by any club member. No club member will profit personally from the resale of COCCC merchandise or any item bearing the club's logos or titles.

Article 4: Initiation Fees and Dues.

Section 1.

Dues for active members are as set by a vote of the membership in good standing, per year, per family, due January 1 of each year. Dues are considered delinquent after March 1.

Section 2.

The dues paid are non-refundable for any reason.

Article 5: Officers & Duties.

Section 1.

The elected officers of the club include: President, Co-2nd Vice Presidents, Secretary, Treasurer and Show Chairperson(s). (The newsletter editor is to be appointed by the membership) The office of 1st Vice President is a non-elected position which will be filled by the immediate past President.

Section 2.

President: The President will preside over all meetings of the club, schedule regular elections and be sure they are held in accordance with this constitution, represent the club at any function for which a specific representative has not been selected.

Section 3.

1st Vice President: Will assist the President and will perform all duties of the President in his/her absence.

Section 4.

Co-2nd Vice Presidents: Will act as ex-officio member of all committees and chairperson of monthly activities. He/she shall also be the Activity Chairperson.

Section 5.

Secretary: Will record and maintain the minutes of the meetings of the club, maintain membership records, supervise all records of the club and handle correspondence.

Section 6.

Treasurer: The Treasurer will collect dues, collect all other income due the club, maintain financial accounting books and supplies. Make payment from club funds when so directed,

make a monthly report of the club's financial status to the membership.

Section 7.

Show Chairperson: Will spearhead the efforts toward producing the club's annual car shows. Will work with all other organizations involved with the club's annual shows. Will assist the President with efforts to coordinate club member duties and functions for the show.

Section 8.

Newsletter editor will publish and distribute a newsletter to the membership and organizations as ordered by membership.

Article 6: Elections

Section 1.

All members for any office must be an active member in good standing.

Section 2.

All elected and/or appointed officers must remain active members in good standing for the duration of their terms in office.

Section 3.

All officers are elected at the August meeting and will assume office at the next regular business meeting.

Section 4.

All officer's terms shall be for the period of 12 months, or until successors are duly elected and qualified.

Section 5.

All "elected" officers may run for the same office more than once, if they so desire.

Section 6.

Nominations will be made from the floor during a regular meeting called by the President, or members may volunteer for office during that meeting.

Section 7.

Elected officers will be decided by a majority of votes cast. All voting will be made by written ballot.

Section 8.

The ballot will always include a line for write in votes.

Article 7: Meetings.

Section 1.

A quorum shall be defined as a majority of total active membership of the association present (President's discretion).

Section 2.

Regular business meetings will be held once a month at a time and place set forth by the membership. In addition to regular business meetings, an attempt will be made to hold social events monthly.

Section 3.

Special membership meetings may be called by the President, with minutes to be taken as per a regular monthly meeting.

Section 4.

Special officer and committee meetings may be called by the president, without full

membership present.

Section 5.

The suggested order of business for all meetings is as follows:

- A. Call to order.
- B. Roll call and introduction of visitors.
- C. Reading and approval of minutes from previous meeting.
- D. Secretary's report.
- E. Treasurer's report.
- F. Committee reports.
- G. Reading of correspondence.
- H. Unfinished business
- I. New business (must give prior notice to the President).
- J. Announcements.
- K. Adjournment.

Section 6.

Regular standing committees are:

- A. Telephone committee (chaired by the Co-2nd Vice Presidents).
- B. Car show committee (chaired by the Show Chairperson).

Article 8. Delegations.


Section 1.
